Rules for participation in International Conference organized by Colway International in Shanghai, China in qualifying period 25.09.2018 – 08.07.2019 (39/2018 OR- 27/2019 OR)

§1. General provisions

1.1. The organizer of the International Conference in Shanghai is COLWAY INTERNATIONAL S.A., with its registered office in Koleczkowo, at the address 84-207 Koleczkowo, ul. Hippiczna 2, entered into the Register of Entrepreneurs kept by the District Court Gdańsk-Północ in Gdańsk, VIII Commercial Department of the National Court Register under KRS number 0000547402, with NIP number 5272731683, REGON 360987881, with share capital of PLN 100,000 fully paid-up, ["Organizer"]. The organizer reserves the right to use specialized entities for this purpose.

1.2. The International Conference in Shanghai ["Conference"] takes place at the date and place indicated by the Organizer and is closed. In the case of circumstances independent of the Organizer, the Organizer reserves the right to change the date and place of the Conference.

1.3. The provisions of these Regulations form an integral part of the Application for participation in the Conference and are binding for all Participants.

1.4. The participants of the Conference are the Organizer's Partners within the meaning of the Regulations of Cooperation who have met the conditions set out in these Regulations.

1.5. The conference will include, in particular, training sessions, workshops, discussion panels, participation of special guests and other attractions, ["Program"] indicated in the announcement of the planned Conference, ["Announcement"]. The announcement will indicate the insurance coverage of the Conference participants.

§2. Participation in the Conference

2.1. Any Partner who meets the qualifying conditions of the Organizer, ["Qualifications"] and receives from the Organizer a personal invitation to participate in the Conference, ["Invitation"] may be a Participant of the Conference. During the qualification period, the organizer will announce the list of people who have completed the Qualifications, as well as the information on the number of missing Settlement Periods to meet them.

2.2. . Qualifications include

2.2.1 the Partner's annual Qualification Period, while for the purposes of these Regulations, the Annual Qualification Period shall be understood as the period from September 25, 2018 to July 8, 2019 (from 39/2018 OR - 27/2019 OR. The inclusion of the Annual Qualification Period does not require additional notification and takes place automatically, and

2.2.2. obtaining and maintaining or maintaining a previously obtained paid Rank defined in point 2.2.3. of the Regulations for a specified number of Settlement Periods falling within the Qualification Period, with the premium Settlement Periods not having to follow each other. Additionally, for the awarding of the

Invitation by the Organizer, the criterion for qualifying or deciding on a partial payment is also the fact whether the Partner has already qualified for free participation in the Conference (regardless of whether the Partner actually took part in it).

2.2.3. As part of the Qualifications in the Conference, the following categories are distinguished::

Qualification Table

*in the above-mentioned period you should promote at least 1 Partner who will qualify to the conference for the first time. This qualification should take place in the Personal Group understood as a group up to the nearest Partner in the rank of VD or higher, who at least once participated in the Foreign Conference Cl.

The price indicated in the Qualification Table means the value of the Invitation. In case of qualifying for a partial value of the Invitation, obtaining a full Invitation for a Partner or an accompanying person will require the Partner to additionally pay the Organizer the missing percentage of the Invitation.

2.3. The Partner who has completed the Qualifications will receive from the Organizer a personal Invitation to participate in the Conference. The invitations may be single or double, i.e. they include one accompanying person depending on the Qualifications obtained. Ones who have received a single Invitation will be entitled to finance the participation of one accompanying person on their own. The amount of the additional payment for an accompanying person is dependent on the Settlement Periods in which the Partner obtained and maintained the paid Rank, as mentioned in § 2.2.3 of these Regulations. Invitations cannot be transferred in any way to others, nor are they subject to cashing.

2.4. The costs of participation, stay and organization of the Participant's travel from designated places to the place where the Conference takes place and the costs of implementing the Conference Program are covered by the Organizer.

2.5. Each Participant will receive a message via e-mail confirming participation in the Conference.

§3. Indication of accompanying persons, resignation from participation in the Conference, date of the Conference

3.1. Within 14 days from the date of receiving the invitation, the Participant who has received the double Invitation should indicate to the Organizer the accompanying person, along with the data necessary to enable participation in the Conference. The above is also applicable to an accompanying person whose participation is financed by the Participant.

3.2. The participant may resign from participation in the Conference before confirming the participation. The Participant's resignation from participation in the Conference should be made in writing and via email within 5 days from the date of receiving the Invitation. In the event of resignation of the Participant after financing the costs of an accompanying person, the Participant is not entitled to claim reimbursement of these costs from the Organizer. However, if the Organizer receives the reimbursement of the costs of participants and their accompanying persons in whole or in part from the host of the Conference, he will make a corresponding refund to them.

3.3. Qualifying to participate in the Conference, and not taking part in it, due to the Partner's resignation, may have an impact on obtaining Qualifications in subsequent Conferences.

3.4. At the latest after the end of the Qualification Period, the Organizer will give in a customary manner the date of the Conference and details of the place and its course. The expected date of the conference is September / October 2019.

§4. Final Provisions

4.1. In case of the cancelation of the Conference due to the reasons beyond the Organizer's control, in cases "Force majeure" (e.g. flood, hurricane, snowstorm, etc.), as well as changes in economic or political conditions for which the Organizer is not responsible, the Participant is not entitled to compensation or to refund any fees or costs related to participation in the Conference, as well as costs of additional services commissioned to the Organizer by the Conference participants.

4.2. Any disputes that may arise from participation in the Conference will be settled by the court competent for the seat of the Organizer, unless otherwise stated in the mandatory provisions.

4.3. Sending confirmation of participation posted on the Conference website means acceptance of the provisions of these Regulations, as well as compliance with the order regulations and any other arrangements made between the Participant and the Organizer.

4.4. The regulations of the law of the Republic of Poland apply to the Regulations. In matters not covered by these Regulations, the provisions of the Civil Code shall apply.

4.5. In accordance with the Personal Data Protection Act of 29 August 1997 (Journal of Laws 133 of October 29, 1997, item 833.), the Conference Organizer does not transfer, sell or lend collected personal data of Participants to other persons or institutions. Personal data provided by the Participant is treated as confidential information and is used only for communication purposes between the Participant and the Conference Organizer. The conference is closed and does not constitute a mass event within the meaning of the Act of March 23, 2009 on the safety of mass events (Journal of Laws of 2009 No. 62, item 504).

4.6. The organizer is not responsible for the items of Participants that may be lost, damaged or stolen during the Conference.

4.7. Participants bear full financial responsibility for their destruction both on the premises where any activities related to the Conference are carried out, as well as in accommodation areas.

4.8. These Regulations shall enter into force on the day of posting on the website www.colwayinternational. com.

4.9. . The organizer has the right to change the provisions of the Regulations. The changes come into force within 7 days of being posted on the website www.colwayinternational.com.

The Regulations are effective from September 27, 2018.
